



RULES AND REQUIREMENTS BEFORE ENTERING:

- Please take note that Opulent Models South Africa is not a pageant and also not an agency. It is a modelling competition scouting new talent in South Africa.
- **ONLY** South African citizens are allowed to enter for Opulent Models South Africa. Entrants must have a valid passport/SA ID or Birth Certificate.
- The competition is open to:

✓ Male and Female contestants may NOT be married, or have been divorced before, and are not allowed to have children.

- You need to act professional at all times.

- All semi-finalists and finalists will be required to do fundraising and sell tickets for the events such as the round of the semi-finals and Grand Finale. Please note you will not be allowed to compete in Opulent Models South Africa if you have not sold all your tickets and completed your fund raising unless decided otherwise.
- Contestants and parents are expected to behave in a professional manner and any interference, whatever the nature, shall not be tolerated.
- Contestants agree that they do not have the right to make any press releases whatsoever, without the consent of the organisers.
- You will receive a reference letter from Opulent Models South Africa which you can use when sending your CV to companies for future job applications.
- Opulent Models South Africa are not responsible for any injuries or expenses of being a selected contestant for our competition.
- Prizes received during the contestant's journey are not refundable for cash.
- Judging criteria is as per international standards.
- The judges' decision is final where Opulent Models South Africa will appoint a male and female model winner for South Africa.
- The judge's decision is also final when also selecting a male and female runner-up model.
- Please take note any prizes and goodies your received during your journey with Opulent Models needs to be promoted on social-media from the sponsorship and relevant brands and companies needs to be tagged-in.
- Please do take note all finalists that will be going through to the Grand Finale will have a compulsory 3-hour extended workshop with Suzette Marais for R350 payable with your signed contract.

- Entry fee and workshop fee are non-refundable should the grand finale or workshop be cancelled or postponed due to the following reasons/factors, which may include but are not limited to,

**GENERAL RULES AND REQUIREMENTS AS A WINNER/RUNNER-UP FOR

- All official interviews conducted by the winner(s) are mandatory.

- If the winner(s) conduct themselves in a manner not befitting the title, they will be disqualified and a suitable replacement will be selected.
 - If the winner is disqualified or chooses to relinquish the title, all prizes, awards and cash value shall be returned in full to be given to the next choice of the judges.
- The winner(s) will be available for their sponsors for appearances for free, if decided otherwise.
